

Effective with the six-months ending September 30, 2020, AAM will transition to a more simplified news media report format with consolidated reporting categories. The transition to the simplified format will be complete with the March 2021 statement period. Below is a category map outlining how circulation is distributed into the different reporting categories for the six-months ending September 30, 2020, and where the circulation will be reported in March 2021, once the transition is complete.
