AUDIT EXECUTIVE SUMMARY:

"Ocean Mist Farms" is an organization that grows packs and stores vegetables in Castroville, CA. The audit was conducted in the facility operation that has 120000 feet² approx, which includes cold storage and a processing area (not part of this report). The product flow basically is comprised of receiving, storing, cooling, re-packing, storing, and shipping. The cooling process includes the use of recirculated water systems with antimicrobials, such as ice injectors or hydrovacuum, which are considered CCP#1. No single pass water systems are used. The water source is the city. The product can also be re-packed by hand. During the inspection, Fennel is re-packed. The operation runs product year-round with a workforce of 47-50 workers. The audit was conducted in one day.
