

COVID 19 Close Contact Class Notification

Hocking Technical College, Driver Education Program

We all have an important role to play in keeping our fellow students, families, friends, and the Hocking College Community safe by doing our part to stop the spread of COVID 19. As a student and a parent of the community at Hocking College, we know that we must take steps to stay well in order to protect others and promote a safe environment on campus for all. Because of this, we pledge to take responsibility for our health and the importance of stopping the spread of COVID 19.

The safety of all who visit and use our campus is Hocking College's highest priority. We know that by engaging in, and attending classes, participating in classroom activities, and driving behind the wheel, participants may be exposed to COVID 19 and other infections. We also understand that despite all reasonable efforts made by the College, students and visitors may still contract COVID 19 and other infections.

In order to reduce the risk of infection, we agree to be active participants in maintaining our own health, wellbeing, and safety, as well as the safety of others by following all the guidelines and expectations outlined by Hocking College.

We agree to:

A **daily check-in** before participating in Driver Education Classes, or a Behind the Wheel session so staff can take my temperature, ask screening questions, and provide me with a color-coded wristband that I will wear at all times while the student is on the Hocking College campus or in the Driver Education car.

When possible, I (student) will physically distance myself a minimum of six feet **unless it is not possible to carry out the outcomes of the driver education program** (ie. behind the wheel driving instruction). **In this situation, we understand the risk, and have decided to go forward with the Driver Education Classes and the Behind the Wheel portions with the safety protocols** that have been established by Hocking College as outlined in this document and also located at hocking.edu/covid.

We understand that we **must wear a mask/face covering that covers my nose, mouth, and chin** while on the Hocking College campus, vehicle or outside when it is not possible to practice social distancing of at least six feet.

We agree to immediately notify Hocking College at 740-753-6506, and/or covid@hocking.edu, should the driver education student test positive, live with someone who has tested positive, or live with someone that has symptoms that are NOT routine health issues. Please include the student first and last name, parent phone number, and where you can easily be reached.

COVID 19 Procedure for the Classroom and the Driver Education Car

Driver Education Classroom

The tables, chairs, desks, counters, door handles, restrooms, and any other high usage touch points, will be disinfected after each classroom session in accordance with Hocking College COVID 19 procedures and CDC recommendations. The Hocking College instructor/staff will carry out these duties.

Driver Education Car

The vehicle will be disinfected after each Behind the Wheel session. Generally this is a 2 hour session for teens, and a 1 hour session for adults, but it is understood that the disinfecting will take place between the change of student drivers behind the wheel of the vehicle. During the drive, the rear windows will be cracked to allow air to exit the interior of the car, and the fan will be run to circulate air from the front of the car to the back of the car to assist the removal of stale air, and to decrease the opportunities for recirculated air in the interior of the car. This will also be done in accordance with Hocking College COVID 19 procedures and CDC recommendations. The Hocking College instructor/staff will carry out these duties.

We ask that if you are experiencing symptoms or have been around someone that has tested positive or is having symptoms of COVID 19, PLEASE stay home and reschedule your class or drive time for the safety of all.
