

**FACTS****WHAT DOES LANDED DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and income</li> <li>▪ Credit history and credit scores</li> <li>▪ Loan information, such as principal, rate and term</li> <li>▪ Home purchase related information</li> <li>▪ Employment information and checking account information</li> </ul>
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Landed, Inc. and Landed Hawaii, LLC ("Landed") chooses to share; and whether you can limit this sharing.

<b>How does Landed collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ Apply for a Landed transaction</li> <li>▪ Provide employment information</li> <li>▪ Give us your contact information</li> <li>▪ Direct others, including lenders or real estate professionals, to provide us information on your behalf</li> <li>▪ Coordinate and close and Landed transaction</li> </ul> <p>We may also collect your personal information from others, such as credit bureaus, affiliates, or other companies. <b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes— information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	<p>Your choices will apply unless you tell us otherwise. Any account holder may express a privacy preference on behalf of the other joint account holder.</p>

## Definitions

<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies such as Landed Management Company, LLC, , Landed Educators, LLC, Landed Educators II, LLC, Landed Educators III, LLC, Landed Fund GP, LLC, and Landed Home Loans LLC.</p>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies</p>

that together market financial products or services to you.

### Other important information

**Do Not Call Policy:** This notice constitutes Landed's Do Not Call Policy under the Telephone Consumer Protection Act for all consumers. Landed maintains an internal Do Not Call preference list. Do not call requests will be honored within 30 days and will be effective for at least five years from the date of request. No telemarketing calls will be made to residential or cellular phone numbers that appear on the Landed Do Not Call list.

**California:** Under California law, we will not share information we collect about you with companies outside of Landed, unless the law allows. For example, we may share information with your consent, to service your accounts, or to provide rewards or benefits you are entitled to. We will limit sharing among our companies to the extent required by California law.
