Cyber Liability & Privacy Protection insurance is designed to address the exposures Insureds face when using the internet, email, websites, computer programs and in particular from storing private information about their clients.

What do we Cover?

1. Third Party Claims:

From failure to keep data secure, including claims for compensation, investigations, payment of fines and penalties. We will also pay defence costs and legal representation expenses.

2. Business Interruption:

Reimbursement for lost income, as well as necessary expenses incurred to maintain operation of the business as a result of the interruption.

3. Response Costs:

Reimbursement of the Insured's own costs including monitoring costs, post-event consulting costs, data restoration, notification costs, public relations costs, and legal representation expenses.

4. Key Automatic Extensions:

Cover is also available for botnetting and phreaking expenses and cyber extortion demands. We also offer cover for court attendance costs and hardware repair or replacement costs.

5. Social Engineering & Cyber Fraud:

Cover for Social Engineering and Cyber Fraud is also available as an Optional Extension subject to Underwriting Criteria.
