**Acclaimed Journalist and Author Mollie Hemingway Selected as a
2021 Bradley Prize Winner**

Award recognizes extraordinary talent, dedication to American exceptionalism

Milwaukee, WI - [The Lynde and Harry Bradley Foundation](#) announced today that noted journalist, author, and commentator Mollie Hemingway is one of three winners of the 2021 Bradley Prizes. The honor recognizes individuals whose outstanding achievements reflect The Bradley Foundation's mission to restore, strengthen, and protect the principles and institutions of American exceptionalism. Hemingway will receive the award at the 17th annual Bradley Prizes ceremony on Monday, September 13th at the National Building Museum in Washington, D.C.

"Mollie is a 'must-read' journalist for her sharp analysis, comprehensive research, and insightful reporting," said Rick Graber, president and CEO of The Bradley Foundation. "She has a keen understanding for how current events impact our freedoms, which she thoughtfully weaves into her writing. The Bradley Foundation is proud to honor Mollie with a Bradley Prize for her significant contributions to the dialogue on the hallmark issues of our time."

Hemingway provides unique and thoughtful reporting and analysis of American politics and culture. She helped launch and is a senior editor of the online magazine *The Federalist*, which has become one of the most influential voices in politics and has millions of readers. She is a senior journalism fellow at Hillsdale College. A *Fox News* contributor, she is a regular member of the Fox News All-Stars panel on "*Special Report with Bret Baier*."

Hemingway is the co-author of the national best-seller *Justice on Trial: The Kavanaugh Confirmation and the Future of the Supreme Court*. Her latest book, *Rigged: How the Media, Big Tech, and the Democrats Seized our Elections*, will be out October 12th.

Hemingway has been profiled in the *New York Times* and her work has appeared in the *Wall Street Journal*, *USA Today*, *Los Angeles Times*, *The Guardian*, *The Washington Post*, *The Atlantic*, *CNN*, *Claremont Review of Books*, *National Review*, *Christianity Today*, *Radio & Records*, and many other publications. She was a 2004 recipient of a Phillips Foundation Journalism Fellowship and a 2014 Lincoln Fellow of the Claremont Institute.

This year's award winners were chosen by the Bradley Prizes Selection Committee, a group of notable leaders in various fields, after careful review of over 100 distinguished nominations. Each award carries a stipend of \$250,000.
