MSBFIRSTDAY SWEEPSTAKES OFFICIAL RULES

No Purchase Necessary to Enter or Win.

- 1. <u>DESCRIPTION OF THE SWEEPSTAKES</u>. The "Heartland School Solutions MSBFirstDay Sweepstakes" (the "Sweepstakes") is sponsored by Heartland School Solutions, located at 765 Jefferson Rd #400, Rochester, NY 14623 ("Heartland"). The Sweepstakes begins on or about July 19, 2021 at 8:00 a.m. Eastern Time ("ET") and ends on September 24, 2021 at 10:00 p.m. ET (the "Promotion Period"). At the end of the Promotion Period, a random drawing will be conducted to select up to seven (7) winners and one (1) grand prize winner from among all eligible entries received, as set forth more fully below. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Heartland, which shall be final and binding in all respects. In the event there is a conflict between Sweepstakes materials and these Official Rules, these Official Rules shall prevail and govern.

You must be the parent or legal guardian of any child featured in your Photo. The Website's database clock will be the official timekeeper for this Sweepstakes. Selected winners must respond to Heartland within 48 hours in order to claim their prize. If, however, subpart (vi) is found to be invalid, unenforceable or illegal, then the entirety of this arbitration provision shall be null and void, and neither entrant nor Sponsor shall be entitled to arbitrate their dispute.
