

#MSBGIVESTHANKS SWEEPSTAKES OFFICIAL RULES

- DESCRIPTION OF THE SWEEPSTAKES.** The “#MSBGivesThanks Photo Contest” (the “**Sweepstakes**”) is sponsored by Heartland School Solutions (“**Heartland**”). The Sweepstakes begins on or about November 15, 2021, at 8:00 a.m. Eastern Time (“**ET**”) and ends on November 26, 2021, at 10:00 p.m. ET (the “**Promotion Period**”). On November, 29, 2021, a random drawing will be conducted to select multiple winners from among all eligible entries received, as set forth more fully below. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Heartland, which shall be final and binding in all respects. In the event there is a conflict between Sweepstakes materials and these Official Rules, these Official Rules shall prevail and govern.
- WHO MAY ENTER.** The Sweepstakes is open only to those legal residents and citizens of the United States (the “**Territory**”) who are at least 18 years of age or older at the time of entry. Officers, directors and employees of Heartland and persons who are immediate family members of any such directors, officers and employees (collectively “**Promotion Entities**”) are not eligible to enter or win. The Sweepstakes is void where restricted or prohibited by law. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. Participants must have an active MySchoolBucks account to be eligible to participate.
- HOW TO ENTER.** To participate in the Sweepstakes, each entrant must visit the MySchoolBucks website at www.myschoolbucks.com (the “**Website**”), download and complete the Gives Thanks printable (the “**Printable**”) and post a picture of your child with the Printable (the “**Photo**”) to your Facebook or Instagram account with the hashtag #MSBGivesThanks during the Promotion Period. Information submitted in connection with the Sweepstakes will be treated in accordance with these Official Rules and the privacy policy located at <https://www.myschoolbucks.com/ver2/etc/getprivacy>. Any communication or information transmitted to Heartland and/or the Website by electronic mail or otherwise will be treated as non-confidential and nonproprietary. Entrants are providing information to Heartland and not to Facebook or Instagram.
- ENTRY REQUIREMENTS.** Each entry into the Sweepstakes must meet ALL of the requirements set forth herein to be considered. Entries must be timely submitted during the Promotion Period. You must be the parent or legal guardian of any child featured in your Photo.
- WINNER SELECTION.** At the end of the Promotion Period, winners will be selected throughout the back to school season in Heartland’s sole discretion. The drawing will be conducted by Heartland or its designee, using randomization methods selected by Heartland in its sole discretion. A potential winner will be notified via direct message on their Instagram or Facebook account, as applicable. Heartland shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If any potential winner does not respond within the time required by Heartland, or if the winner notification is returned as unclaimed or undeliverable to any potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason, such potential winner will be disqualified and the prize may be awarded to the next highest entry.
- PRIZES.** Five winners will be selected and will each receive a prize of a \$100 American Express gift card. Prizes will be awarded only if each potential prize winner fully complies with these Official Rules. All portions of the prizes are non-assignable and non-transferable. All details and other restrictions of the prizes not specified in these Official Rules will be determined by Heartland in its sole discretion. - DATES & DEADLINES/ANTICIPATED NUMBER OF CONTESTANTS.** Heartland reserves the right, to modify any date(s) or deadline(s) set forth in these Official Rules or otherwise governing the Sweepstakes. Heartland cannot accurately predict the number of contestants who will participate in the Sweepstakes.
- PUBLICITY RELEASE/LICENSE TO USE/REPRESENTATIONS AND WARRANTIES.** Each entrant represents and warrants that they are the parent or legal guardian of the child featured in the Photo. By participating in the Sweepstakes, each entrant irrevocably grants the Promotion Entities and their respective successors, assigns and licensees, the right to use such entrant’s Photo, name, user name, likeness, and biographical information in any and all media for any purpose, including without limitation advertising and promotional purposes, as well as in, on or in connection with the Website, MySchoolBucks, or the Sweepstakes or other promotions conducted by the Promotion Entities, and each entrant hereby releases the Promotion Entities from any liability with respect thereto.

Heartland reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Heartland reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by a duly authorized representative of Heartland. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
