Completion of Website Blue Acquisition - Cleansing Notice

PropTechGroup Limited (ASX: PTG)) (**Company**) advises that, further to its announcement on 23 February 2021, it has now completed the acquisition of JMCG Pty Ltd t/a Website Blue and has today issued 1,623,774 new fully paid ordinary shares (**Consideration Shares**) as partial consideration for the acquisition as detailed in the accompanying Appendix 2A.
