

VOLLY AWARDS - OFFICIAL RULES

1. PROMOTION DESCRIPTION: The Volly Award ("Award Sweepstakes") begins on September 1, 2021 at midnight and ends on May 31, 2022 at midnight (the "Promotion Period").

The sponsor of the Volly Awards is Booster Enterprises ("Sponsor"). By participating in the Volly Awards, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of nominations and the overall administration of the Volly Awards. 4. HOW TO ENTER: Enter the Volly Awards during the Promotion Period online by visiting the entry form, which can be found on the following website at vollyawards.com.

Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Any attempt by Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/Volly Awards subscription notification and/or entering services, will void Entrant's Entries and that Entrant may be disqualified. Sponsor's database clock will be the official timekeeper for this Volly Awards.

5. WINNER SELECTION: The Winner(s) of the monthly Volly Award will be selected by a committee of internal Sponsor employees and an external agency from among all eligible Entries received throughout the Promotion Period. The committee is reviewing submissions for the following criteria:

- Volunteer's involvement level with the school
- Impact of commitment to school and community
- Quality and details of nomination submission

The selection will be conducted 5 days after the Promotion Period by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible Entries received.

The final winner will be announced to the public the week of July 11, 2022. The final annual winner will be used in marketing materials (including digital marketing) in following years to help the promotion of Volly Awards.

WINNER NOTIFICATION: The person who nominated the Winner will be notified by email at the email address provided in the Entry Information approximately 6 days after the nomination period ends each month. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive email account(s), technical difficulties associated therewith, or Winner's failure to adequately monitor any email account. If the

selected winner is not responsive within 5 days, the Sponsor will select a new winner from the nominations.

Any winner notification not responded to or returned as undeliverable may result in prize forfeiture. If a potential winner cannot be contacted, fails to timely claim the prize, is disqualified, fails to timely execute and return any required forms, or if the prize notification is returned as undeliverable, an alternate winner will be selected by Sponsor. This celebration will be documented and by selecting no, the nominee is removing themselves from the selection process.
