By this agreement, the league is applying for affiliation with the California Youth Soccer Association, Inc., a California non-profit public benefit corporation, for the youth soccer season commencing on September 1st of the seasonal year and ending August 31 of the following year.

Rule 1:05:03: All member leagues, their teams and players, shall abide by the Constitution and Bylaws of the California Youth Soccer Association, Inc., the United States Youth Soccer Association, and the United States Soccer Federation; All General Procedures and Specific Rules as set forth by the Board of Directors and all applicable rules and regulations of the United States Youth Soccer Association and the United States Soccer Federation.

D&O insurance is not required, but is recommended.

All new leagues must submit proof of Non-Profit status, a copy of the league's bylaws, and a copy of the approved Articles of Incorporation. Returning leagues must provide any changes to the articles of incorporation and/or bylaws.

This agreement must be signed by a league officer and submitted with payment of \$200.00 to your District Commissioner no later than February 15th (or earlier date if set by your District Commissioner), and must be submitted by the District Commissioner to the Cal North State Office no later than March 1st prior to the beginning of the seasonal year.

All league affiliation applications and appropriate fees must be IN THE Cal North OFFICE BY THE 1ST OF MARCH prior to the begining of the seasonal year in the Fall. Penalties for failure to meet the deadline as stated are as follows: Not in by March 1st \$50.00 fine; Not in by April 1st \$100.00 fine, League to be put on probation for the following year.

WE WILL ABIDE BY THE RULES AND REGULATIONS OF THE CALIFORNIA YOUTH SOCCER ASSOCIATION, INC., AND ANY RULES AND REGULATIONS HEREAFTER MADE.
