The Executive Director has made a preliminary decision to approve above-referenced Alternate Means of Control (AMOC) Plan. This preliminary approval is based on the representations and demonstrations provided to date. A copy of the preliminarily approved AMOC plan, public notice, and instructions are enclosed.

Bayport is now required to publish Notice of Intent to Obtain an AMOC Plan in accordance with the Texas Commission on Environmental Quality (TCEQ) rules in Title 30 Texas Administrative Code § 115.914(3) and § 115.915. Bayport will provide copies of the affirmation of Public Notice to the TCEQ, EPA Region 6, and any local program with jurisdiction over the site. Comments will be accepted on the plans, and you are welcome submit comments during the public comment period. The Executive Director will consider and prepare a written response to all significant and timely written comments regarding the AMOC plans and, in response to the comments, may modify the provisions of the AMOC plan, deny the AMOC plan, or approve the AMOC plan without changes. The EPA Regional Office, any local program, and each person who submitted timely written comments will receive the Executive Directors' final AMOC Plan determination, with the response to comments and notice of the opportunity to appeal the determination to the Commission.
