NACCHO ABORIGINAL MALE HEALTHY FUTURES BLUE PRINT

There are a range of options as to how the Blue Print might be dealt with in the session i.e. It could be:

- ▶ endorsed by the conference to demonstrate that it still has currency or;
- ▶ it could be endorsed as an interim National Strategy subject to a review at some time in the future or;
- ▶ the meeting could make some other decision regarding its relevance.
- ▶ The meeting could recommend that a new National Strategy be developed.

A decision to endorse it as an interim National Strategy subject to a review in the future should also consider a process, timeframe and the makeup of the review team.

If the review is to be conducted within a reasonable timeframe the review team would have to commence meeting within a short time frame after this conference.

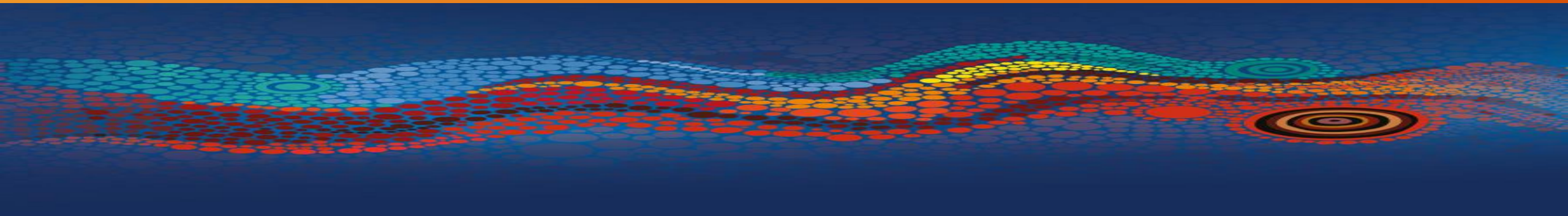


NEW NATIONAL ABORIGINAL MALE HEALTH STRATEGY

In the event that it is recommended that a new National Strategy be developed a process, team, auspicing body and a funding agency would have to be identified. The auspicing body would require the alibility to consult with ACCHOs.
