My partner and I have lived in Beeler Park since June 2018, and like everyone else, navigated living in this brand-new neighborhood and finishing up landscaping and house projects. Even with a new home, there are so many projects to complete. This is a vibrant new neighborhood, with so much to offer all of us. Previous to living in Beeler Park, we lived in Park Hill, Capital Hill and Congress Park, and Mayfair.

If I am chosen to be the delegate to represent Beeler Park, I have valid experience that can be tapped for growth in many exciting areas. One area of development is cultural programming. Working in the non-profit world for over a decade, coupled with my previous career at Home Deport, I have experience managing educational programming. One aspect of cultural programming, which hasn't been addressed in the neighborhood, is DIY Workshops. Classes organized and taught by neighbor's expert in a number of areas can focus on such topics as landscaping, tree care, and basic home repairs.
