
TALKAPHONE LLC LIMITED WARRANTY

An "Installation Certification" card is enclosed with every unit. In the event that no "Installation Certification" is received by Talkaphone, the twenty-four (24) months will commence on the date of shipment by Talkaphone. Warranty period for Models ETP-MT Tower, ETP-MT/R Radius Tower, WEBS-MT/R Radius Tower, WEBS-PM Pedestal Mount, and ETP-PM Pedestal Mount is five (5) years, under the same terms and conditions. Warranty period for Intercommunication Products is three (3) months, under the same terms and conditions. In the event this product is found by Talkaphone to be defective within the warranty period, Talkaphone's only obligation and your exclusive remedy, shall be the repair and/or replacement of any defective parts, provided the equipment is returned to Talkaphone LLC., 7530 N. Natchez Ave., Niles, IL 60714. It is expressly understood that Talkaphone shall have no obligation to furnish labor, nor pay for the labor of any third parties, nor bear the expense of shipping defective products for repair. This warranty shall not apply if Talkaphone determines that the defect was caused by improper use or installation, or damage caused to the equipment by others.
