Florida	√	Service contracts (relating to service, maintenance or repair) that are automatically renewed for a period of more than one month if the renewal causes the service contract to be in effect more than six months after the day of the initiation of the service contract.
Georgia	√	Service contracts with automatic renewal provisions for more than one month if the renewal means the service contract is in effect more than six months after the date of initiation.
Hawaii	√	Service contracts for products or services with a term of more than one month that
