

2020 NIADA | NABD Virtual Convention and Expo Series Virtual Expo Hall Drawing Official Contest Rules

Entry Period:

The **2020 NIADA | NABD Virtual Convention and Expo Series Virtual Expo Hall Drawing** (“Drawing”) begins on September 28, at 12:00 a.m. Central Time (“CT”) and ends on October 9, 2020, at 5:59 p.m. CT (the “Entry Period”), during which time all entries must be received in order to be eligible.

Eligibility:

Drawing participants must be at least 18 years old and living in the United States. The National Independent Automobile Dealers Association (“NIADA”), NIADA Services, Inc., NIADA Foundation employees and members of the Boards of Directors, and/or Board of Trustees, respectively, and their immediate families are not eligible to win. Immediate family includes parents, spouse, children, siblings, grandparents and each of their respective spouses or households (whether related or not) of any of the preceding. **By participating in the Drawing, you agree to be bound by these Official Rules and the decisions of the NIADA Board of Directors, which are final.** Void where prohibited or restricted by law. How to Enter:

(a) You will be automatically entered if you properly complete and timely submit the 2020 Virtual Hall Scavenger Hunt form found on niadaconvention.com. Completed forms must be submitted by 5:59 pm CDT on October 9, 2020.

Cards must be received by 5:59 pm CDT on October 9, 2020. Only one mail-in entry per person will be accepted. No facsimile, email or copied entries will be accepted.

All entries become the property of NIADA and will not be acknowledged or returned. Each entry request must be separately mailed. NIADA is not responsible for lost or misdirected mail entries. Entries received after expiration of the Entry Period will be deemed invalid.

No purchase or payment is required to enter the Sweepstakes, nor does a purchase or payment increase your chance of winning a prize.

- A cash prize of two thousand five hundred dollars (estimated retail value \$2,500)

Selection of Winners:

The four (4) prize winners will be determined by a random selection from all eligible entries received during the Entry Period. Selection will take place on October 13, 2020, at the NIADA offices, 2521 Brown Blvd., Arlington, TX 76006. Winner selection will be conducted by the NIADA. By participating, you agree to be bound by the selection of the winners by the NIADA, which shall be final and binding in all respects. **The odds of winning depend on the total number of eligible entries received.**

Winners need not be present to win. After the drawing, winners will be notified based on the name and information on the entry. Winner notification will be made by telephone, email, U.S. Mail, overnight courier, and/or in person at NIADA's discretion.

To redeem the prize, winners must be located and claim their prizes within seven (7) days of notification or all claims to prizes are forfeited and alternate winners will be selected.
