



NOTICE AND ACCESS NOTIFICATION TO SHAREHOLDERS

You are receiving this notification as Secure Energy Services Inc. ("SECURE") has elected to use the notice and access model ("Notice and Access") for the delivery of meeting materials to its shareholders who do not hold their common shares of SECURE ("SECURE Common Shares") in their own name (the "Beneficial Shareholders") in respect of its special meeting of shareholders concerning the plan of arrangement involving SECURE and Tervita Corporation to be held on June 15, 2021 (the "Meeting").

Under Notice and Access, instead of receiving paper copies of SECURE and Tervita Corporation's joint management information circular dated May 6, 2021 (the "Circular"), Beneficial Shareholders are receiving this notice with information on how they may access the Circular electronically. SECURE is providing this notice to all Beneficial Shareholders. The use of this alternative means of delivery is more environmentally friendly as it will help reduce paper use and it will also reduce SECURE's printing and mailing costs.

SHAREHOLDERS WILL BE ASKED TO CONSIDER AND VOTE ON THE FOLLOWING MATTERS:

Share Issuance Resolution: Shareholders will be asked to approve, with or without variation, an ordinary resolution, the full text of which is set forth in Appendix B to the Circular, authorizing and approving the issuance of such number of SECURE Common Shares as are required to be issued pursuant to a plan of arrangement under section 193 of the *Business Corporations Act* (Alberta) involving, among others, Tervita Corporation and SECURE, all as more particularly described in the Circular.

SHAREHOLDERS ARE REMINDED TO REVIEW THE CIRCULAR BEFORE VOTING. Information respecting the Share Issuance Resolution may be found in the "*Matters to be Considered at the SECURE Meeting*" section of the Circular.
