

Level 2 | Minimal Suppression (Effective: 19 July 2020)

Community Health

- In public places:
- » maintain minimum 3ft (~1m) distance
- » wear face mask or covering inside public places and for taxis, ride-sharing, and public transportation
- Public gatherings limited to 50 people
- Processions and festive ceremonies remain prohibited
- Visits to households allowed
- Testing continues

Essential Activities

- Limited restrictions remain:
- » Seated table service at restaurants and bars
- » Activities, including exercise and access to beaches and waterways, subject to public gathering restrictions and maintaining minimum 3ft (~1m) distance
- Undertake all journeys safely by following current Public Health quidelines



Education & Human Services

- External careaivers and domestic helpers allowed in the home
- Educational institutions and facilities, including summer camps and vacation Bible schools, may operate using quidance provided social and sporting activities permitted
- » Children 6 years and older to wear a mask while indoors
- Visits to institutional care homes permitted with negative COVID-19 test within three days prior to visit - maintain minimum 6ft (~2m) distance and take additional safety measures
- No visits to:
- » patients in hospitals
- » places of detention
- » places of augrantine or isolation
- Utilise technology to interact with others including children, older persons, and other vulnerable friends and family without putting them at risk



Business & Services

- Operations limit customers to maintain minimum 3ft (~1m) distance
- Restaurants and bars subject to specific public health protocols - dancing and karaoke permitted with minimum 3ft (~1m) distancing between all persons
- Use of hookahs, shisha pipes, or water pipes not permitted
- Safety protocols may be issued by regulators and industry associations
- Staff may return to physical workplaces if safety measures such as physical distancing can be maintained
- Flexible work arrangements encouraged
- Remote working for all that can do so



Cultural, Social & Recreational

- Cultural, social & recreational activities limited to 50 people and maintainina minimum 3ft (~1m) distance
- Contact sports permitted with up to 50 participants, including coaches and support staff, and up to 50 spectators – spectators must maintain minimum 3ft (~1m) distance
- Places of worship to limit congregants to allow for physical distancing



Transport & Travel

- Public transport and taxi service to operate:
- » limited to half of total seating capacity
- » staggered seating
- » driver and passengers wearing masks
- Boats only to operate within the Cayman Islands' territórial waters, limited to 50% maximum capacity or up to 50 people, whichever is lesser, to allow for minimum 6ft (~2m) distancing
- Inter-island travel via air and boat permitted without COVID-19 testing if traveller has been in the Cayman Islands for two weeks or more
- Emergency international travel only

At this Level:

- Visit https://www.exploregov.ky/government-covid19-policies for the COVID-19 policies and Regulations currently in force
- Always be sure to follow current Public Health guidelines including practicing physical distancing, hand hygiene, and mask-wearing this represents the 'new reality'
- Activities, venues may only operate if current Public Health quidelines (including physical distancing and gathering restrictions) are followed and other legal requirements can be met
- Employers may require employees to work remotely and should introduce flexible working arrangements to comply with current Public Health guidelines
- Vulnerable populations (in particular elderly, immunocompromised, high-risk) should continue to take additional precautions and personal protective measures
