Community Health

- In public places:
 - » maintain 6ft/2m distance
 - » wear face mask or covering indoors
 - » gradual increase in public gatherings – now up to 25 people
- Public meetings, processions and festive ceremonies remain prohibited
- Visits to households allowed
- Testing continues



Essential Activities

- No hard curfew
- No shelter-in-place or “soft” curfew
- Movement not restricted by surname
- Limited restrictions remain:
 - » Food collection and outdoor seated table service only at restaurants and bars
 - » Activities, including exercise and access to beaches and waterways, subject to public gathering restrictions and maintaining 6ft/2m distance
- Avoid unnecessary journeys



Education & Human Services

- External caregivers and domestic helpers allowed in the home
- Early childhood centres may operate from 5 July 2020
- Educational institutions and facilities, including summer camps and Vacation Bible Schools, may operate from 5 July 2020
- Distance learning, collection of materials continues
- No visits to patients in hospitals, prisons and detention facilities, or places of isolation or quarantine
- Visits to institutional care homes with written permission
- Utilise technology to interact with children, older persons, and other vulnerable friends and family without putting them at risk



Business & Services

- Restaurants and bars subject to specific public health protocols – no dancing or karaoke permitted
- Safety protocols may be issued by regulators and industry associations
- Rental of scuba and snorkelling equipment limited to tanks
- Staff may return to physical workplaces if safety measures such as physical distancing can be maintained
- Customers must be limited to allow for physical distancing between all persons
- **Flexible working arrangements encouraged**
- **Remote working for all that can do so**



Cultural, Social & Recreational

- All gyms and indoor sport facilities remain closed, including private strata gyms
- All beach and waterway access for all activities, every day
- Exercise limited to 25 people
- Only open air non-contact sports permitted, up to 25 people
- Scuba diving using own equipment only – only tanks may be rented
- Places of worship open and subject to safety protocols including physical distancing and mask-wearing
- Other indoor social venues including cinemas and theatres may operate – nightclubs remain closed
- Social gatherings inside the residence or private yard space allowed with people from outside the household
- Follow specified limits for attendance at weddings and funerals



Transport & Travel

- Public transport and taxi service to operate:
 - » limited to half of total seating capacity
 - » staggered seating
 - » driver and passengers wearing masks
- Boats only to operate within the Cayman Islands' territorial waters, limited to 10 people total per boat or gathering of boats
- No congregating, boating or fishing at Starfish Point, Rum Point, Sandbar, or Stingray City
- No travel to Cayman Brac and Little Cayman via boat except with permission to transport cargo or persons providing essential services
- Emergency international and essential domestic travel only; specific measures in place for domestic travel to and from all ports

At all Levels:

- Visit <https://www.explore.gov.ky/government-covid19-policies> for the COVID-19 policies and Regulations currently in force
- Always be sure to follow current Public Health guidelines including practicing physical distancing and hand hygiene – this represents the 'new reality'
- Always be sure to follow curfew provisions issued in accordance with Section 49 of the Police Law
- Activities, venues may only operate if current Public Health guidelines (including 6ft/2m physical distancing and gathering restrictions) are followed and other legal requirements can be met
- Employers may require employees to work remotely and should introduce flexible working arrangements to comply with current Public Health guidelines
- The Competent Authority may issue specific exemptions for additional businesses to operate and for individuals to undertake additional essential travel
- Vulnerable populations (in particular elderly, immunocompromised, high-risk) should continue to take additional precautions and personal protective measures
- Movement to avoid the risk of injury or death (eg. to seek health care or escape from domestic violence) and to comply with court-ordered or formal child custody/visitation arrangements always allowed
