## COOKIES POLICY

AT Global Markets (UK) Limited ("ATFX") are the owners and providers of [www.ATFX.com/uk/](http://www.ATFX.com/uk/) website address (the "Website") and this document sets out to users ("Users") of the site ATFX's policy in respect of the use of cookies on the Website and its sub-domains. This Cookies Policy applies only to the actions of ATFX and Users with respect to the Website itself and does not extend to any websites that can be accessed via it including, but not limited to, any links to social media websites.

### What are cookies?

Cookies are small pieces of text stored on your computer when you visit a website.

They are not programs and cannot be executed as code or deliver viruses - instead cookies act more like a passport, which the site checks and updates whenever you visit.

Almost every site on the internet uses cookies and their functions include:

- verifying your identity for security purposes
- determining the type of browser and settings you are using
- allowing site owners and third-party advertisers to tailor content to your preferences

### Our policy

We respect your privacy and are committed to providing you with the information and tools you need to manage your cookies.

There are three types of cookies on this site:

**Essential cookies** are necessary for the vital functions of our site and trading platform. If these are disabled, you won't be able to access the platform or other important parts of the site.

**Behavioural and analytical cookies** help us provide you with a better service. They can tailor site content to your personal preferences and past behavior, or remember your saved settings.

**Marketing cookies** enable you to experience more relevant online content and see adverts which are aligned with your interests, as indicated by your activity on our site.

### Essential cookies

**Some parts of our website, particularly our trading platform, require these essential cookies in order to function.**

If they are disabled you will be unable to use our trading platform and some areas of our website won't function correctly.

## Analytical cookies

**This type of cookie helps us understand the way visitors and clients use our website, so we can provide a better service.**

We use the data from behavioural and analytical cookies to improve our site and provide individually tailored content. These cookies make it easier for you to find the information you need and allow us to adapt our site to suit your preferences.

Some of the systems we use to track web traffic and site usage are provided by third-party companies such as Google.

We and some third-party companies use this type of cookie to provide advertising that is more relevant to you.

When visiting other sites where these cookies are recognised, you should be presented with content that is in line with your interests based on your activity on our site.

Facebook Pixel	Facebook ad manager	This Cookie is placed by Facebook. It enables ATFX to measure, optimize and build audiences for advertising campaigns served on Facebook. In particular it enables ATFX to see how our users move between devices when accessing the ATFX web site and Facebook, to ensure that ATFX's Facebook advertising is seen by our users most likely to be interested in such advertising by analysing which content a user has viewed and interacted with on the ATFX web site.
