Return Instructions

NOTECustomers are responsible for return freight charges***

- 1. Fill out the attached form and fax to 800.711.6515. Our returns department will review form and notify customer via fax if item (s) are approved to be returned.
- 2. If return is after 30 days of purchase, credit will be issued for purchase price or current market value, whichever price is lower.
- 3. Items must be in original container and factory sealed.
- 4. Make sure that items are packaged securely for return. <u>Credit will be denied if items</u> are damaged due to improper packaging.
 - a. Liquids should be in a sealed bag.
 - b. Boxed items such as creams and ointments should be double boxed to prevent crushing.
 - c. Glass should be bubble wrapped.
 - d. Cooler items must be packaged properly inside a cooler or a cooler envelope with an ice pack inside. Must be notated on box that there is a refrigerated item enclosed. NEVER return these items on Thursday or Friday due to package being left with courier.
- 5. Please leave price stickers attached to the bottles.
- 6. Make sure a copy of the form is enclosed.
