The initial privacy audit via industry-specific questionnaires takes about 3-6 months (first step: select applicable processes and tools)








INDUSTRY-SPECIFIC QUESTIONNAIRES (2/4)

During the audit we collect 800-1,500 data points about your company using intelligent questionnaires, which comprise our core and secondary process audits









EVALUATION OF AUDIT DATA (3/4)

Our platform automatically evaluates your answers and generates guidelines (highlights, flags, suggestions), which your expert will discuss with you during follow-up sessions







PRIVACY POLICY GENERATOR





With the DSR Tool we enable you to implement a form on your website, so that your data subjects can file data subject requests (DSRs) through it.


The DSRs sent via this form are gathered in the DSR dashboard on the platform, where they can be managed and processed according to our guidance - and within the due date.




NEWS DASHBOARD
