

APPENDIX 4 CARRIAGE OF PETS UNDER THE PET TRAVEL SCHEME (PETS)

JetBee is a DEFRA approved operator and can carry pets (dogs, cats, and ferrets) within our European service area. When travelling into the UK from Europe, JetBee is authorised only to operate into certain airports and additional procedures must be followed.

With JetBee Czech Airlines, you can fly with your pet in all safety and comfort in the cabin only. Depending on the animal and your destination, different rules and regulations apply. Travelling with an animal is subject to availability and must be booked in advance.

General Conditions of carriage for pets

- Any passenger intending to bring a pet onboard an JetBee flight must notify JetBee in advance and receive approval. Any animals arriving on the day will be declined carriage.
- JetBee must be informed of the breed, age, and weight of the animal.
- A mix of passengers and live animals should only be allowed for pets weighing not more than 8 kg and guide dogs. Animals should be properly secured in the suitable containers or bags. Two containers/bags are allowed on board as maximum. The location of the containers shall not obstruct the emergency exits and should be such that, in the event of an emergency evacuation, it will not hinder egress nor impair the crew's view.
- Passengers are responsible for loading and unloading the animal themselves in order to prevent injury or distress to the animal.
- The Commander reserves the right to exercise his discretion. Any animals that he believes to be oversized, or that do not have a means to be restrained may be declined carriage.
- Any pet export, import or transit permits, Health and/or vaccination certificates, Pet passport/ID or other documents required by airport authorities must be provided in advance of the flight in compliance with local regulations on pet travel.

* Seeing-eye, hearing or assistant dogs (no restrictions in size or weight) can travel onboard JetBee, by special permission from the Flight Ops Manager.

CONDITIONS FOR ACCEPTANCE

ANIMAL

- Above 12 weeks old
- Clean and healthy
- Calm and well behaved
- Kept in a soft-sided, leak- and smell-proof bag during the entire flight
- Has to remain completely inside the bag (including tail and head)
- May be pregnant (proof of the veterinary is required certifying that the animal is fit to travel)

BAG / CONTAINER

- Leak- and smell-proof
- Soft-sided bag, to be stowed completely under the seat in front of you
- Within the size of 118cm / 45 inch (max. total dimensions)
- To be provided by you
- Max. 1 bag per passenger is allowed
- 2 adult pets may travel in the same bag provided they are comfortable with each other (total max. weight of 8kg / 18lbs, including the bag)
- 3 small pets (max. 6 months old) may travel in the same bag, only when from the same litter (total max. weight of 8kg / 18lbs, including the bag)

Pet strollers must be checked in as part of your checked baggage allowance. They may not be used in the airport or transported on board as hand baggage.

Snub-nosed cat and dog breeds have anatomically restricted airways. Transportation and temperature changes at your departure, transfer and destination airports can cause stress and circulatory issues that may result in breathing problems. This means that your pet could suffer serious health problems or even die during the journey.

For this reason, these pets:

- Does not accept the transportation of these pets in the hold (AVIH)
- Accepts these pets in the cabin (PETC)

Pet Travel Scheme (PETS)

The Pet Travel Scheme (PETS) is the system that allows:

- Pet dogs, cats and ferrets from certain countries and territories to enter the UK without quarantine as long as they meet the rules.
- People in the UK to take their dogs, cats and ferrets to other European Union (EU) and certain non-EU countries and territories, and return with them to the UK without the need for quarantine.

The rules are to keep the UK free from rabies and certain other diseases.

Pets are free to travel within the UK, The Channel Islands, and The Republic of Ireland, and may use any airport without restriction. For those entering the UK from continental Europe, JetBee is approved under the Pet Travel Scheme (PETS) to operate into London Biggin Hill (EGKB/BOH), London Stansted (EGSS/STN), Blackpool (EGNH/BLK), Bristol (EGGD/BRS), Doncaster Sheffield (EGCN/DSA), Glasgow (EGPF/GLA), Liverpool (EGGP/LPL) airports. In order for the pet to travel, a full copy of the pet passport including all vaccination pages must be provided in advance of the flight.

Before your pet enters the UK, it must be treated against ticks and a tapeworm – Treatment must be administered by a vet not less than 24 hours and not more than 120 hours before the scheduled departure time with JetBee for its journey into the UK.



Travelling to Jersey

In addition to London, JetBee is approved by the States of Jersey Department for the Environment to arrive into Jersey with pets also. Please consult JetBee Sales if this is of interest.

Pets are not accepted in the cabin on flights to the United Kingdom.

However, cats, dogs and ferrets are accepted on flights to London Heathrow under the UK Pet Travel Scheme when shipped as Cargo. The pet owner is responsible for ensuring that the pet meets all the rules for entering the UK under the Pet Travel Scheme. Under no circumstances will Airlines accept liability or incur costs for the failure of the clearance of pets, due to incorrect documentation.

EU regulations

On 1 October 2004, the EU launched new regulations for the transportation of pets, applicable to the transport of cats and dogs between both Member States and from third countries into the EU:

The pet originates from the European Union and travels within the European Union or to a country outside the EU that is recognised as safe (*see below) and returns to the European Union: In such cases, the pet needs a passport, ID and proof of anti-rabies vaccination.

The pet originates from the European Union, travels to a country outside the EU that is not recognised as safe and returns to the European Union: In such cases, the pet needs a passport, ID, proof of anti-rabies vaccination and proof that a blood control had been done 30 days after vaccination but before departure.

The pet does not originate from the European Union but from a country that is recognised as safe and travels to the EU: In such cases, the pet needs an ID, proof of anti-rabies vaccination and a health certificate according to the EU-model.

The pet does not originate from the European Union or from a country that is recognised as safe and travels to the EU: In such cases, the pet needs an ID, proof of anti-rabies vaccination, a certificate of vaccination respecting the EU model and proof that a blood control had been done 30 days after vaccination but before departure.

Malta, UK, Ireland and Cyprus: Beside the above requirements, you are also required to show proof of tick treatment and tapeworm treatment.

Finland requests proof of tapeworm treatment.



* Countries that are recognised as safe: Ascension Island, Antigua and Barbuda, Netherlands Antilles, Australia, Aruba, Barbados, Bahrain, Bermuda, Canada, Fiji, Falkland Islands, Croatia, Jamaica, Japan, St Kitts and Nevis, Cayman Islands, Montserrat, Mauritius, New Caledonia, New Zealand, French Polynesia, St. Pierre et Miquelon, Singapore, St. Helena, USA, St Vincent and the Grenadines, Vanuatu, Wallis and Futuna, Mayotte.

All animals, **other than cats and dogs**, must be shipped as cargo in accordance with the IATA Live Animals Regulation.

- Rodents
- Rabbits
- Fish
- Birds
- Large domestic animals (> 8kg)
- Wild animals

Emotional support animals: You may travel with your emotional support animal in the cabin for free on these flights, as long as the animal is permitted to travel in the aircraft cabin.
