## Frequently Asked Questions (FAQ)

How will I know how many CEUs are approved for each WorkWell course? In addition to the table above, the CEU value and total contact hours will be included on your certificate of completion for each course you complete. How does Michigan APTA approval help me if I am a PT that doesn't live in Michigan? Many state boards will accept relevant coursework approved by an APTA chapter in a different state. Please check with your individual state board to verify requirements for your state.

What if my state does not accept courses approved by an APTA chapter in a different state? Some states will allow you to submit courses for continuing education approval in your own state. Submission requirements and fees will vary by state. You may submit your certificate of course completion to your individual state board for approval, if needed. In some cases, individual state boards will require additional information. Once you find out what information is required, please contact provider@workwellpc.com with your request for information and we will be happy to provide you with the requested information.

AOTA: WorkWell has been granted status as an AOTA Approved Provider for Continuing Education.
