



WFP Income Fund Announces an 8.05% Net Annualized Return through August 31, 2015

September 1, 2015, Los Angeles, California - The WFP Income Fund, managed by Wilshire Finance Partners, paid investors an 8.05% net annualized non-compounded return through August 31, 2015. The net annualized compounded return through the same period was 8.24%.

The WFP Income Fund is a short term alternative fixed income investment that seeks to protect the investor's principal while also providing attractive risk-adjusted returns primarily through investments in loans secured by first trust deeds and mortgages within the United States.

At month end, the portfolio had a weighted average loan-to-value of approximately 56.67%; a weighted average maturity of approximately 23 months; and 0% non-performing assets. The fund had an average loan size of approximately \$760,616, consisting of loans primarily secured by residential, office, retail, and warehouse properties located in the State of California. The fund started the process of reviewing and underwriting loans in a select number of other states and during the month of August funded a \$1,050,000 first mortgage with a 34% loan-to-value secured by an office building in Tallahassee, Florida.

The return obtained by the fund was on an unlevered basis and was primarily the result of interest income received on the first trust deeds and mortgages in the fund's portfolio.

"The decrease in the annualized yield is unrelated to the recent volatility in the securities markets or the speculation surrounding Federal Reserve action related to interest rates," said Don Pelgrim, CEO of Wilshire Finance Partners. "The dip in returns is tied to a period of under-deployed capital in the fund during August as a result of the following: first, a large amount of new investment capital entered the fund on August 1st; second, the fund experienced some significant loan repayments early in the month; and, lastly, we had several new loan closings push into late August. The result was the fund had capital earmarked for certain loans that remained idle during a portion of the month which created a drag on returns. By month end, a large portion of that capital was redeployed into new loans and there were loans in the pipeline that we anticipate closing in September that will result in better deployment of the fund's capital."
