



Biosimilars: The Next Frontier

The launch of biosimilars in the US introduces competition to a trending specialty drug marketplace. Biosimilars are approved by the FDA for safety and are certified for “having no meaningful clinical difference” from their reference drugs. The nature of biologics makes it impossible to manufacture exact duplicates, as is the case with generics. A biosimilar is as much like a reference product as are distinct batches of the reference product! With savings estimated at \$54 billion over ten years, we must address the market failures that are inhibiting adoption. Ultimately, the impact on affordability can improve access and support medication adherence.

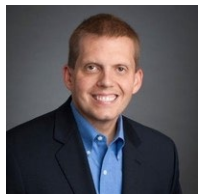
